

**DECISIONS TAKEN AT THE CKC-AAA FOURTEENTH ANNUAL CONVENTION,
AT LOS ANGELES, CA on 24 JULY 2010**

We, the members of the Christ the King College Onitsha Alumni Association In America, Inc. (CKC-AAA), a 501 (c) 3 non-profit, tax-exempt entity, meeting at our Fourteenth Annual Convention and General Assembly, in Los Angeles CA, 23-25 July 2010.

1. **Having considered** the 2010 Report on the State of CKC-AAA, and the Implementation of the 1999 *Los Angeles Plan of Action* and the 2004 *Washington DC Follow-Up Plan of Action* submitted jointly by the President of CKC-AAA and the Chairmen of the Finance and Endowment Fund and the Project Implementation and Management Committees, and the 2009-2010 State of the School Report submitted by Mr. Emmanuel Ezenduka, Principal C.K.C. Onitsha;
2. **Reaffirms** our commitment to the motto of Christ the King College, Onitsha: *Bonitas, Disciplina Scientia* and to keeping our collective aspiration that CKC and its alumni must remain, *Primus Inter Pares*, (First Among Equals); and the values espoused in our convention theme and mission statement, “**Rebranding Education**”;
3. **Welcomes** the appointment of Mr. Emmanuel Ezenduka, (Class of ’73), as the 21st Principal of the College;
4. **Pay tribute to and commends**
 - a. The founders, builders, custodians, and departed and presents alumni, staff and students of our great Alma Mater;
 - b. **Mr. Emma Onua**, President of CKC-AAA and his Excom colleagues for their selfless service, dedication, commitment and leadership during their two-year tenure from 2008-2010;
 - c. **Chief Joe Billy Ekwunife**, Acting President-General of CKC Onitsha National Old Boys Association, Members of the CKC Old Boys NEC and NAPOC and Principal Emmanuel Ezenduka for their cooperation with CKC-AAA;
 - d. **H. E. Sam Dada Olisa**, the 2010 Convention and Charles Okoye Memorial Alumni Keynote Speaker;
 - e. **Hon. E. Eloho Otobo**, Director & Deputy Head of the UN Peacebuilding Support Office and the 2010 Convention Guest Keynote Speaker;
 - f. Messrs **Ugo Boniface Anakwenze(CA), and Charles Ikenna Okoye(IL)**, the recipients of the CKC-AAA 2010 **Exceptional Service Award (ESA)**;
 - g. Our hosts, CKC-AAA California Chapter; and the City of Los Angeles, for their warm hospitality;
 - h. CKC Onitsha alumni resident in the Americas, who have contributed generously to the “**CKC Revitalization/ Diamond Jubilee Trust Fund**”; and supported ongoing revitalization efforts at CKC Onitsha;
5. **Elects**

The following persons as its officers for 2010-2012; **Mr. Emma ONUA** (President); **Mr. Ben EHIRIM** (Vice-President); **Mr. Oseloka OBAZE** (Secretary); **Mr. Eugene AGBIMSON**(Financial-Secretary); **Mr. Stanley OFOMATA** (Treasurer) and **Mr. Emeka AKUDINOBI**(Public Relations Officer); and to reappoint **Mr. Patrick EJIKE** (Agent); **Rev. Ugo Paul ARINZE** (Chaplain); appoint **Mr. Emma ONUA** (Interim Webmaster);and reconstitute the Standing Committees;
6. **Decides**
 - a. To continue our collaborative efforts with His Grace Archbishop Valerian M. Okeke, the Archbishop of the Metropolitan Archdiocese of Onitsha and the Proprietor Christ the King College, Onitsha on all matters relating to the advancement, revitalization and sustenance of Christ the King College, Onitsha;
 - b. **Not to embark upon any new capital revitalization project on the CKC campus** until the decisions relating to previously approved revitalization projects are implemented and the projects under reference fully executed.
7. **Approves**
 - a. That CKC-AAA Executives carry out their mandate pursuant to the Los Angles Plan of Action, the Washington DC Follow-Up Plan of Action , 2010 Convention Mission Statement and these decisions;
 - b. The disbursement during **FY 2011 of Four Hundred Thousand only (N400,000.00)** as follows:
 - One Hundred Thousand Naira (**N100,000.00**) to service CKC-AAA Annual Motivational Award for the “Best Tutor” and “Best Student” in 2011; and
 - One Hundred Thousand Naira (**N100, 000.00**) to service the “School Principal’s’ Unforeseen Emergency Expense Fund for 2011;
 - One Hundred Thousand Naira (**N100, 000.00**) in equal share, as a one time university academic scholarship to the four (4) most deserving graduating seniors in 2011; and
 - One Hundred Thousand Naira (**N100, 000.00**) to the NEC cover CKC-AAA dues for 2010-2014;
8. **Confirms** the holding of the Fifteenth Annual Convention and General Assembly of CKC-AAA in New York and therefore, decides to meet one year from now, on **15-17 July 2011**.
9. **Requests** CKC-AAA Executives to continue discharging the mandate given to them by selflessly serving the Association; and to report to the 2011 Convention progress made on implementing the 2004 Washington DC Follow-Up Plan of Action and particularly, the mandate in paragraph 6, 7 and 8 above. **[END]**
